To the Shareholders of Manutencoop Facility Management S.p.A.

- 1. We have audited the financial statements of Manutencoop Facility Management S.p.A. as of December 31, 2014 and for the year then ended, comprising the statement of financial position, the statement of profit or loss, the statement of other comprehensive income, the statement of changes in Shareholders' equity, the statement of cash flows and the related explanatory notes. The preparation of these financial statements in accordance with International Financial Reporting Standards as adopted by the European Union is the responsibility of Manutencoop Facility Management S.p.A.'s management board. Our responsibility is to express an opinion on these financial statements based on our audit.
